Introduction

The meeting was brought to order with Mrs. Jones explaining the ABC icebreaker exercise. It was followed by everyone in attendance introducing themselves.

New Items

The April meeting minutes were approved by Jackie Trachsel, 2nd by Taryn Tissiere. All in attendance were in favor. Elected officers (President, Vice President, and Secretary positions) were approved by Julie Wenger, 2nd by Amanda Bachman. All in attendance were in favor.

Committee Updates

Allyson provided a brief overview of designated committees, including duties and protocol. She discussed room parent sign ups.

Taryn Tissiere provided an update on this summer's golf outing. We brought in around \$4700 in profits, from mostly sponsorships. Next year's goal is to increase attendance.

Adelle Masching provided an update on upcoming Reading Night. This year's theme is "Tackling Literacy." Students and parents are encouraged to wear orange and blue. There will be cards for each family to fill out with a possible raffle giveaway. The book fair will be set up, along with various activities/reading in some classrooms. Adelle also stated profits from this summer's Bob N Ringo's restaurant night were around \$450. The plan is to schedule a date for Joe's Pizza next.

Julie Wenger spoke about Quick Draw sales. About 127 alumni tickets had been sold so far. She expects totals to increase based on the number of tickets she's had printed and handed out. Jackie Trachsel stated this round's Spirit Wear made around \$730. The group discussed doing another round of orders leading up to Christmas.

Staff Reports

Mrs. Jones discussed Gratitude for Grandparents. Women's Guild will set up and serve breakfast, but are requesting volunteers starting at 6:15 AM. For TAPS members interested, the first Women's Guild meeting is scheduled for Tuesday, September 19th at 5:30 PM.

Mr. Lawrence was unable to attend, but left printouts of mock uniforms for 7th and 8th grade boys' basketball. Cheerleaders will be meeting tonight to be measured. Uniforms plan to be ordered ASAP following budget approval. The next uniforms to be ordered will be girls' basketball, followed by volleyball. We will be hosting regionals and sectionals for both girls and boys basketball this year.

Donna Gray reviewed numbers – totals in each financial account and the major spending of recent months for this month's financial report. Printouts were provided. Amanda Lauritsen discussed the current CD, which was established to meet needs for technology updates. The group will need to decide to cash out or renew prior to November 30th of this year. Donna discussed which expenses come from which type of accounts.

Allyson reviewed this year's proposed budget, reviewing each line item and some teacher wish list items. Each teacher was offered one wish list item of their choosing in proposed budget. Some items may be covered by grant money. Other needs, such as future uniform spending and a new gym floor were discussed for planning purposes. The budget approval was led by Joe Richardson, 2nd by Taryn Tissiere. All present were in favor.
